## Beerstock Grows Again In 2011

Beerstock 5060-3 took place in Orting, WA on August 6th. The annual festival is held to celebrate the passage of Washington Senate Bill 5060 in 2009 that legalized the transport of homebrew. Up until then it was technically illegal to enjoy your homebrew anywhere but in the privacy of your own home.

Homebrewers from all over Washington state have gathered at Beerstock for the last three years to share their brews and network with other homebrewers.

Beerstock grew again for the third year in its existence despite a change in venue from the previous two years. In 2009 there were 85 brewers and guests in attendance, in 2010 it grew to 180 and this year it reached 203 people. There were 18 brew clubs that came to Orting this year including from as far away as Kitsap County, Bellingham and the Tri-Cities.

After the explosive growth last year, it was evident Beerstock had outgrown Mark & Alison Sheafor-Joy's property near Bryant, WA. After much searching it was decided to hold Beerstock 5060-3 at a private park just outside of Orting in Pierce County. The venue is a water-ski park with expansive flat grassy areas for setting up the club booths and for camping.

This year's Beerstock festival was also practice for the National Homebrew Conference that will be held in Seattle over June 21-23, 2012. One of the main events of the NHC is Club Night. Much like Beerstock, clubs from all over the country will set up booths with fun themes and share their homebrew and network with fellow homebrewers.

The NHC is held in a different city around the country each year. Being one of the largest clubs in Washington state, GEBL will be called upon to make the 2012 NHC a big success and represent the Seattle area as a great host city and a great homebrew town.

# Competition Focus

## Mead BJCP Categories 24 - 26



In celebration of AHA National Mead Day on August 6th, this month's column will focus on Mead styles, and some mead-only competitions. I have extensively referenced, and highly recommend for further mead reading, the BJCP Mead Study Guide.

It's taken a while but summer has finally arrived in Washington. With this heat and the warm August nights many homebrews seek a more ancient beverage to enjoy and brew. In it's simplest form, mead is a fermented alcoholic beverage made from honey, water, and yeast. Because of it's similarities to wine, some people erroneously call mead 'honey wine.' However, in order for something to be wine it must contain crushed grape juice.



In BJCP sanctioned competitions, mead is judged on it's balance, which is the synergy of all the components that formulate an enjoyable tasting experience: aroma (bouquet), flavor (taste, honey flavor), structure (tannin, acid, and alcohol), residual sweetness, and mouthfeel (body, carbonation). In a balanced mead, individual components do not overshadow one another, and the resulting combination is appropriate for the particular style of mead. The use of words like synergy, balance, and harmony shouldn't imply that all flavors are of equal intensity.

While not all homebrew competitions include mead categories, there are some competitions that are only for mead styles such as the long running Mazer Cup, Muse Cup, and Valhalla. The Washington Mead & Cider Cup is a local competition with a mead focus as well being a WHoTY qualifier. All of these can be found in the competition schedule in this newsletter.

**Labeling mead styles for competition** - This information must be passed to judges in order to properly evaluate a competition mead.

### Mandatory Requirements

- Entrants **MUST** specify carbonation level (still; pétillant or lightly carbonated; sparkling or highly carbonated).
- Entrants **MUST** specify strength level (hydromel or light mead; standard mead; sack or strong mead).
- Entrants **MUST** specify sweetness level (dry; semi-sweet; sweet).

Mead style classifications are roughly broken down by the following (trust your senses though):

### AHA Club Only Competition

At the meeting on Thursday we will be evaluating Specialty/Experimental/Historical Beers (BJCP Category 23) per our Club Only Competition guidelines to represent GEBL for the September/October COC hosted by Brewers United Zany Zymurgists (BUZZ) club of West Chester, PA.

If your entry is selected to represent GEBL it will be due in West Chester, PA by October 15 and judging will be held on October 29.

Entries must specify the experimental nature of the beer (e.g. type of special ingredients used, process utilized or historical style being brewed), or why the beer doesn't fit an established style. Additionally, the entrant may specify an underlying beer style. For historical styles or unusual ingredients/techniques that may not be known to beer judges, the brewer should provide descriptions of the styles, ingredients and/or techniques used.

STRENGTH - OG:

hydromel: 1.035 - 1.080

standard: 1.080 - 1.120

sack: 1.120 - 1.170

ABV:

hydromel: 3.5 - 7.5%

standard: 7.5 - 14%

sack: 14 - 18%

SWEETNESS LEVEL - FG:

dry: 0.990 - 1.010

semi-sweet: 1.010 - 1.025

sweet: 1.025 - 1.050

**Optional Requirements:** Entrants MAY specify honey varieties used. If honey varieties are declared, judges will look for the varietal character of the honey. Note that the character of a varietal honey will be identifiable as distinct to the source flowers, but may not resemble the source plant, tree, or fruit. For example, orange-blossom honey has the character of orange blossoms, not oranges; blackberry honey is only distantly like blackberries, although it is an identifiable character.

**Category-Specific Requirements:** Some categories require additional information, particularly in categories other than traditional mead. For example, declaring specific fruit, spices, or special characteristics. Supplemental materials may be provided to judges if an obscure ingredient or method is used.

**Defaults:** If no attributes are specified, judges should evaluate the mead as a semi-sweet, pétillant, standard-strength mead with no varietal honey character and no special ingredients. Competition organizers should make every effort to ensure that judges are provided the full set of attributes of the meads being evaluated.

**NHC 2012 Planner** - The NHC team asked me to put some planning thoughts down concerning National Homebrew Competition. I will add this planner to all my articles for the rest of 2011. You are 8 months away from NHC 1st round competition. In my humble opinion you should have the following ready right now:

- Finalized plan of what styles you are competing in for NHC 2012.
- Compiled ingredients list (especially fruit, honey and hops) and shop the deals now!
- Completed brewing and aged with minimum 9 mos. (high gravity/sour /mead/cider) - Categories 5d, 9e, ALL 17 thru 19, ALL 24 thru 26 and 28.
- Scheduled to brew Aug-Sep, so they can age properly (bocks, porters, stouts) - Categories 5a-c, 9b-c, 12,13, 15b-d, 16c, 22, 21, 27
- On the bubble to brew soon Sep-Oct (Euro Lager, Dark lagers, browns, Belgians) - categories 3, 4, 10c, 11, 16

## GEBL in 2010-2011 AHA Club of the Year Top 25

GEBL tied for 18th place in the AHA Club of the Year Award for 2011 with 40 points total.

AHA clubs earn points for placing 1st, 2nd, or 3rd in each of the six Club-Only Competitions (COC); placing 1st, 2nd, or 3rd in the First Round of the National Homebrew Competition (NHC); and placing 1st, 2nd, or 3rd in the Final Round of the NHC.
